Fraser Coast Women in Development are proud to present Federal Minister Tanya Plibersek

Tanya Plibersek was elected to the Federal Parliament as the member for Sydney in 1998 and became a shadow minister in 2004. During her time as a shadow minister, Tanya was responsible for a wide variety of issues including childcare, work and family, community, women, youth and human services and housing. Following the election of the Rudd Government in 2007, Tanya was appointed the Minister for Housing and the Minister for the Status of Women

As Minister for Housing, Tanya launched the Social Housing Initiative which provided more than 19,300 new public housing units. In December 2008, along with Prime Minister Kevin Rudd, released the Governments White Paper on Homelessness.

As Minister for Status of Women, Tanya addressed the United Nations International Women's Day Event attended by United Nations Secretary General Ban Ki-Moon and announced Australia's formal accession to the United Nations Optional Protocol, which sends a strong message that Australia is serious about promoting gender equality and that we are prepared to be judged by international.
